# CABLE CAR AND SKI RUN REGULATIONS

#### Regulations

- 1. The use of the cable car and the GołębiewSKI ski run takes place during the opening hours of the facility and on the basis of a pre-purchased pass (magnetic card). The owner of the facility reserves the right to change the hours of operation of the facility without giving any reason.
- 2. A refundable deposit is charged for the magnetic card.
- 3. Please consider purchasing points on magnetic cards! The ticket office does not refund money for unused points.
- 4. The purchase of a pass is tantamount to acceptance of the regulations.
- 5. Follow the regulations for the use of magnetic cards. The cable car staff may take away the card for bypassing the gate and failing to cancel the pass, and the customer will not be refunded the deposit and dues for unused rides.
- 6. The cards can only be purchased and returned at the GolębiewSKI ticket offices or the Hotel reception desk.
- 7. Only one person may pass through the gate, using a single opening.

## §1 RULES OF CONDUCT ON THE SLOPE

- 1. Admission to the ski run is allowed only in designated areas.
- 2. Pedestrian traffic and riding down on sleds or other vehicles are prohibited on the ski run.
- 3. The ski run is one-way.
- 4. Every person using the cable car and the slope is required to exercise due diligence to protect the life and health of themselves and others.
- 5. Adjust your speed according to your skills, the type and condition of the route, weather conditions, and traffic.
- 6. Snow conditions are variable and due caution must be exercised.
- 7. Snow moguls, snowdrifts, and icy surfaces are a natural part of the slope such places must be traversed with extreme caution.
- 8. Avoid stopping on the slope.
- 9. All skiers are required to use only the designated ski run, being careful of hydrants, cannons, and other equipment.
- 10. The boundaries of the slope are marked and protected by safety nets.
- 11. Persons leaving the designated downhill ski run do so solely at their own risk.

## §2 REGULATIONS FOR THE USE OF THE CABLE CAR

- 1. Persons using the cable car embark and disembark only in the designated areas, in turn conforming to the rules according to which this device operates.
- 2. If the cable car stops in the middle of a ride, stay calm and wait for traffic to resume or for directions from the staff.

#### Hotel Golebiewski

- 3. The cable car may be stopped due to breakdowns or bad weather conditions.
- 4. It is forbidden to stay (or ride) on the run and in the cable car for persons in an inebriated state or after the use of intoxicants, as well as to bring objects that threaten the safety of others.
- 5. Smoking is prohibited in the cable car.
- 6. Anyone who violates the rules of GolebiewSKI may be removed from the premises.
- 7. A maximum of 4 people may sit on one chair.
- 8. You may embark and disembark only in designated areas.
- 9. After starting the ride, we immediately close the handrail (stick).
- 10. When arriving at the destination station, raise the safety handrail (stick), lower your hands, and wait to reach the disembarkation area. Follow the instructions of the cable car operator.
- 11. Persons under the age of 16 are required to use protective helmets when using the cable car and the slope.
- 12. Children under the age of 12 may use the cable car and the slope only under adult supervision.
- 13. Children with a height of less than 1.25 m may be transported only in a separate position (on the extreme seats of the chairs) under the care of an adult who will provide assistance if needed.
- 14. While riding in the chairs, it is forbidden to: lean, sway, change from one sitting position to another, and open the safety handrail of the chair.
- 15. All loose hanging items of clothing (strings, ribbons, scarves, etc.) must be secured to prevent them from catching on the elements of the chair.
- 16. Skis may be transported only strapped on boots. It is prohibited to carry skis held in the hands.

#### §3

#### INFORMATION FOR PERSONS USING THE CABLE CAR AND THE GOŁĘBIEWSKI SLOPE

- 1. People on the slope are responsible not only for their own behaviour but also for the performance of the ski and snowboard equipment they use.
- 2. Users of the cable car and the slope are required to comply with the rules of order and instructions of the staff, as well as with the information on the boards and the ski run.
- 3. Rescue operations are carried out by paramedics.
- 4. If you notice an accident, report it to the lifeguard on duty or the staff.
- 5. Persons in the area of the GołębiewSKI facility have an absolute duty to give way to teams carrying out rescue operations.
