## Sports equipment rental shop REGULATIONS

## Regulations

- 1. The GołębiewSKI Rental Shop (the "Rental Shop") provides rental of sports equipment.
- 2. The Rental Shop is the owner of the sports equipment that is the subject of the rental.
- 3. The person renting sports equipment (the "Renting Person") presents a document confirming their personal information:
  - a. Guest at the Gołębiewski Hotel: a magnetic card,
  - b. outsider: identity card.
- 4. The Renting Person must be at least 18 years old.
- 5. As confirmation of the rented equipment, the Renting Person receives a rental document containing the following information:
  - a. type of the rented equipment,
  - b. date and time of the equipment rental,
  - c. date and time of the equipment return,
  - d. personal information of the Renting Person.
- 6. With the signing of the rental document, the Renting Person undertakes to comply with the terms and conditions set forth in these regulations.
- 7. The Rental Shop is required to issue to the equipment to the Renting Person in proper condition, fit for its proper and safe use.
- 8. When picking up the rented equipment, the Renting Person should make sure that the equipment is complete and its technical condition allows for its proper and safe use.
- 9. Signing of the rental agreement by the Renting Person is tantamount to confirmation that the equipment received by them is not defective, is complete, and its technical condition allows its proper and safe use. By signing, the Renting Person also accepts the ski boot release force set on the bindings of the rented skis if this type of equipment is rented by them.
- 10. The Renting Person is required to use the rented equipment with care and diligence, and in accordance with its intended use.
- 11. The Renting Person is required to return the rented equipment within the time specified in the rental document, in a condition no worse than at the time of rental.
- 12. The Renting Person is financially liable for the loss or destruction of the rented equipment, as well as for damage thereto resulting from its improper use, both by the Renting Person themselves and by third parties.
- 13. In case of damage to or destruction or loss of the rented equipment, the Rental Shop will add to the rental price the amount of money corresponding to the cost associated with the repair of the rented equipment or the purchase of equipment of similar value to the rented equipment.
- 14. The Renting Person is required to immediately report to the Rental Shop the loss of, destruction of, and any damage to the rented equipment incurred during its use.

## Hotel Golebiewski

- 15. Information on the sports equipment rental prices and details of the billing periods are included in the publicly available price list located in the rental shop.
- 16. The Rental Shop is not responsible for accidents and any injury occurring during the use of the rented equipment. Skiing and snowboarding are extreme sports, requiring fitness, physical condition, and appropriate skills from those who practice them. Beginners are advised to ride with an instructor.
